It is a great pleasure to us to get an opportunity to attend this glorious Council Meeting at this historical place at The Hague.

It is true and clear that Europe is the only Country in the World that can generate a radical and positive change in the global power situation. From the very note of Alberto Meyochi, we came to know " that globalization is a very complex phenomenon and difficult to analyze in its different aspects." We, the Federalists, we support his views. But when all the developing Countries are getting into access in globalization in Economy, Technology, Politics, Peace and Harmony, we feel sorry to know that until date there is no representative from developing Country in UN Security Council. We proposed that there should be a permanent member in Security Council.

The particulars and status of INOWF are as follows.

1. Our organization INOWF is registered being no- S/98765 (copy enclosed) under society Act Govt. of West Bengal (India).
2. We have our Bank Account which being operated by any of the two President, Secretary General and Treasurer since long.
3. Election are held every two years by following democratic procedure.
4. Annual Accounts and Reports audited by reputed Chartered Accountant (enclosed copy) and Annual Report for 2003-04.

5. We are holding our office permanently at 115, Park Street, Kolkata since late M .K. Banerjee , our founder Secretary General respectively established in 1960.

Since last election held in 2004 new office bears (enclosed) elected Mrs. Namita Mullick as President and Mrs. Minati Adhikari as Secretary General.

In view of above we are very much shocked to encounter our past member Mrs. Kalpana Khan Mondal who is resorting to all sorts of anti Association activities. She is not attending to our office since 1999 without any notice. It is understood mat she has formed a parallel organization with the same name as ours via " INOWF", and representing as Council member in WFM which is devoid of all ethics, rules and regulation. The opening of Separate Association in the name of "INOWF" by Mrs. Kalpana Khan Mondal is illegal and undemocratic which should be banned with immediate effect to honour the democratic system. For all her anti Association activities she is suspended from the membership of INOWF.
